

Twelve (12) YEAR WINTER COVER LIMITED WARRANTY

Leslie's Swimming Pool Supplies® (hereinafter, "Leslie's") warrants the Winter Cover to be free from defects in materials and workmanship at the time of purchase by the original owner. This Limited Warranty will remain in effect for a period of TWELVE (12) years after purchase of the Winter Cover, when used under normal use in accordance with the applicable instructions. Should replacement of the Winter Cover during the stated warranty period become necessary, the original warranty remains in effect and a new warranty will NOT be issued.

TWELVE (12) YEAR LIMITED WARRANTY

Note: Before installing your new Winter Cover, please be sure to check it thoroughly to ensure that it is free of defect and the correct size. Once installed, covers are NOT eligible for exchange for existing patent defects or incorrect size.

During the first year of this Limited Warranty, Leslie's will either (at its option) repair free of charge or replace any component of the Winter Cover which, in Leslie's reasonable judgment, proves defective either in workmanship or material.

In the event the Winter Cover is deemed defective under this Limited Warranty, the replacement of the Winter Cover shall be prorated in the following manner for the original purchaser of the Winter Cover:

Year #1: no charge to original purchaser

Year #2: 60% discount (current retail) on purchase of a new winter cover

Year #3: 35% discount (current retail) on purchase of a new winter cover

Year #4: 25% discount (current retail) on purchase of a new winter cover

Year #5: 20% discount (current retail) on purchase of a new winter cover

Year #6: 15% discount (current retail) on purchase of a new winter cover

Year #7: 10% discount (current retail) on purchase of a new winter cover

Year #8-12: 5% discount (current retail) on purchase of a new winter cover

What is covered under this limited warranty:

- Fabric Deterioration: this occurs when the seams that hold the sections of the Winter Cover together start to come apart. With respect to the foregoing warranty, ordinary wear and tear shall not be considered a defect in workmanship or material. Any implied warranties are limited in duration to the TWELVE (12) year period from the date of purchase to the original purchaser.

Leslie's will not be liable for any incidental or consequential damage resulting from any defects in workmanship or material.

What is not covered under this limited warranty:

- Excessive abrasion, holes caused from wear, wind damage, and grommets pulling out are specifically excluded from coverage of this Limited Warranty. In areas of high wind, the anchoring of the cover is most important. The anchoring should prevent any billowing of the cover.
- Damaged caused by the water level of the pool falling by more than 18" below the pool top while the Winter Cover is in use.
- Damage caused by water and/or snow accumulating on top of the cover that is not properly and timely drained or removed.
- Tears, rips, holes and other damage caused by you.
- Damage caused by misuse or animals.
- Winter Covers which have been improperly installed, altered, abused, neglected, subject to accident, improperly serviced or improperly maintained, are specifically excluded from coverage of this Limited Warranty.

THE EXPRESS LIMITED WARRANTY SET FORTH HEREIN IS IN LIEU OF ANY OTHER EXPRESS WARRANTIES, AND ALL IMPLIED WARRANTIES ARE LIMITED IN DURATION TO THE DURATION OF THE EXPRESS WARRANTIES PROVIDED HEREIN. NO PERSON, AGENT, DISTRIBUTOR, DEALER, SERVICE FACILITY OR ENTITY IS AUTHORIZED TO CHANGE, MODIFY OR AMEND THE TERMS OF THIS WARRANTY IN ANY MANNER OR FASHION WHATSOEVER. LESLIE'S SHALL NOT BE LIABLE TO THE PURCHASER(S) OR TO ANY OTHER PERSON(S) FOR DAMAGES ARISING UNDER CONTRACT, NEGLIGENCE, STRICT LIABILITY, TORT OR WARRANTY, OR FOR ANY INCIDENTAL OR CONSEQUENTIAL DAMAGES OR LOSS OF PROFIT OR PRODUCT RESULTING FROM ANY DEFECT IN OR A MALFUNCTION OR FAILURE OF THE WINTER COVER.

Although any warranties implied are limited in duration, some states and/or provinces do not allow limitations on the length of time of an implied warranty. Therefore, the above may not apply in such states and/or provinces. Any claimant under this Limited Warranty has specific legal rights, and the provisions in this Limited Warranty are neither a modification nor subtraction, but rather, an addition to the statutory warranties, and other rights and remedies contained in the applicable state or provincial legislation.

Leslie's will not be liable for any incidental or consequential damages resulting from any defect in materials or workmanship. Some states and/or provinces do not allow the exclusion or limitation of incidental or consequential damages. Therefore, the foregoing limitations or exclusions may not apply.

This Limited Warranty gives the owner of the Winter Cover specific legal rights. The owner also has implied warranty rights. In the event of a problem with warranty service or performance, the original purchaser may go to a small claim's court, a state court or a federal district court.

WARNING:

TO AVOID DROWNING RISK:

- COMPLETELY REMOVE THE COVER BEFORE USING POOL; IT IS POSSIBLE TO GET TRAPPED UNDER THE COVER.
- STAY OFF THE COVER; THE COVER WILL NOT SUPPORT WEIGHT.
- PARENTS: KEEP CHILDREN AND PETS AWAY; THERE IS A DANGER TO CHILDREN AND PETS GETTING ONTO OR UNDER THE COVER. KEEP OBJECTS – ESPECIALLY TOYS – OFF THE COVER SO CHILDREN ARE NOT ATTRACTED. BE ESPECIALLY CAREFUL NOT TO ALLOW CHILDREN INTO THE POOL AREA WITHOUT ADULT SUPERVISION.
- REMOVE STANDING WATER OFF THE COVER, SINCE DROWNING CAN OCCUR ON TOP OF THE COVER.
- THIS IS NOT A SAFETY COVER.

INSTALLATION AND USER INSTRUCTIONS:

CAUTION: THE WINTER POOL COVER IS NOT A SAFETY COVER AND IS NOT DESIGNED TO SUPPORT PEOPLE. CHILDREN SHOULD BE ADVISED. THE WINTER COVER MUST BE REMOVED FROM THE POOL BEFORE SWIMMING TO AVOID RISK OF DROWNING.

IN-GROUND POOL INSTALLATION: The winter cover is installed over the pool with at least 2'-3' of cover material overlapping the deck surface. The overlapped material on the deck then needs to be covered with water bags. Water bags need to cover the entire perimeter of the pool decking to ensure a secure fit. Failure to properly secure the winter cover will lead to tears or rips not covered under the enclosed warranty. The use of a cover pump is required to remove standing water. Standing water can cause damage to the cover and void the enclosed warranty.

ABOVE-GROUND POOL INSTALLATION: The winter cover is installed over the pool with at least 1'-3' of cover material overlapping the top pool railing. The overlapped material needs to be secured with a cable and winch system. The use of above ground water bags, clips, and/or cover wrap cannot be used independently but may be used in conjunction with a cable and winch system to provide a more secure fit. Failure to properly secure the winter cover will lead to tears or rips not covered under the enclosed warranty. The use of a cover pump is required to remove standing water. Standing water can cause damage to the cover and void the enclosed warranty.

MANUAL REMOVAL OF THE COVER: Pull three or four feet of the cover off the pool and repeat in a fanfold manner (accordion fashion) until the entire cover is off the pool surface.

MAINTENANCE AND CARE:

1. Protect the cover when not in use. The cover MUST be protected from the sunlight when it is removed from the pool. The sun generates temperatures hot enough to quickly damage the cover.
2. Care in handling: To prevent damage, the cover should be carefully lifted over abrasive pool decks or coping or any sharp, ragged surface.
3. High temperatures. Water temperatures above 80 degrees F may shorten the life of your winter cover and could also damage your pool as well. If pool temperatures rise above 80 degrees F the cover should be removed. We do not warranty if used in covering spa's in which temperatures exceed 90 degrees F.
4. Storage: After cleaning the winter cover, allow it to dry. Fold it into four-foot widths in a fanfold manner (accordion fashion). Always store it in a shaded or protected area below 120 degrees F.
5. DO NOT leave your cover on the pool during the swimming season. The cover is not a solar cover and its life may be severely shortened by summer conditions.
